

**Resolution #24 – 21/22  
Assessment of Drainage District**

WHEREAS, the Board of Supervisors of Osceola County, Iowa in session on the 8th day of February, 2022, do determine that an assessment should be levied on all the tracts of land, lots, railroad companies and public highways within the boundaries of Drainage District #9 & #43 in Osceola County to procure funds with which to pay the cost anticipated for the general upkeep and maintenance of the aforementioned districts; and

WHEREAS, the Board determined and finds that the reclassified assessment furnishes a fair and equitable basis for a proper apportionment of the costs and expenses of said assessment and the Board concurs that no good reason exists for a different assessment.

THEREFORE, BE IT RESOLVED by the Board of Supervisors of Osceola County, Iowa that the following percentage of original/reclassified assessment be levied on each tract of land, lots, public roads and railroad companies in those districts and that the County Auditor of Osceola County be directed and ordered to extend assessment of the following percentage of the original/reclassified assessment and certify the same to the County Treasurer, to be collected by the Treasurer in the manner as provided by law.
