The Osceola County Board of Supervisors met pursuant to law and adjournment at 8:45 am at the Osceola County Courthouse Board Room in Sibley, Iowa with the following members present: Mike Schulte, LeRoy DeBoer, Jayson Vande Hoef, Ed Jones and Jerry Helmers. Absent: None.

DeBoer moves to approve the March 22, 2022 agenda. Second by Schulte. All vote aye. Motion carried.

It was moved by Schulte, second by Vande Hoef to approve March 18, 2022 minutes. All vote aye. Motion carried.

RESOLUTION #29 21/22

RESOLUTION OF THE BOARD OF SUPERVISORS, OSCEOLA COUNTY, IOWA

Supervisor Jones read the following resolution and moved its adoption:

WHEREAS, the Board of Supervisors is empowered under authority of Section 306.41 of the Code of Iowa to temporarily close sections of road by formal resolution when they deem necessary for construction, maintenance, or natural disaster,

AND WHEREAS, the Board of Supervisors, County of Osceola, have determined that the following section of road should be temporarily closed due to road construction:

#1 4,000' East of Highway 60 on 230th Street Gilman Twp. Sec 14 & 23

#2 900' West of Sorrel Ave on 160th Street Ocheyedon Twp. Sec 6 & 7

#3 1500' East of White Ave on 260th Street Harrison Twp. Sec 27 & 34

NOW, THEREFORE, BE IT RESOLVED, that the above described roads be closed temporarily in the manner described below.

"ROAD CLOSED" signs shall be placed on both ends of the described segment of road, and they shall remain in place until the construction is completed.

Supervisor Schulte seconded the motion to adopt said Resolution - motion carried.

I hereby certify that the above and foregoing Resolution was duly and legally adopted at a legal meeting of the Board of Supervisors of Osceola County, Iowa, and properly journalized in the minutes thereof on the 22nd day of March 2022.

Jones moves to approve Laurie Koerselman as office manager in the engineer's office with a salary of \$36,500. Second by Schulte. Ayes-Jones, Schulte, DeBoer, Helmers. Nay- Vande Hoef. Motion carried.

It was moved by Schulte, second by DeBoer to approve the appointment for Adam Smythe as equipment operator/sign technician with an hourly rate of \$21.80. All vote aye. Motion carried.

DeBoer moves to approve Dean Ackerman to mow at the Enterprise Park. Ackerman will need to provide Certificate of Insurance with the County listed as additional insured. Second by Schulte. All vote aye. Motion carried.

Payroll registers from March 9th and 11th were reviewed.

It was moved by Jones, second by DeBoer to approve claim # 1593 to Bosma Water Service. Ayes- Jones, DeBoer, Schulte, Helmers. Nay- None. Abstain- Vande Hoef. Motion carried. Jones moves to approve the remainder of the claims. Second by Helmers. All vote aye. Motion carried.
