**WITNESSETH:**

1. The above Applicant(s) desires to construct an underground drainage tile for agricultural purposes through the above described Osceola County road right-of-way. Said drainage tile shall be approximately \_\_\_\_\_ inches beneath the ground surface, it shall be \_\_\_\_\_ inches in diameter; it shall enter and exit the road approximately as shown on the above plat; it is expected to drain up to \_\_\_\_\_ acres of real estate; construction shall be started and completed in 20\_\_\_\_; and no other land is to be tiled through this Osceola County road right-of-way except by a separate agreement; and,
2. The Applicant(s) desires the approval of Osceola County to install a drainage tile beneath the aforementioned public highway; and,
3. The Applicant(s) desires permission from the owner on the LOW side to connect into his tile system; and,
4. The Applicant(s) are owners of the real estate which lies adjacent to the road right-of-way; and,
5. All crossings must be constructed normal (perpendicular) to the centerline of road; and
6. The approximate cost of furnishing and placing this tile from right-of-way to; and,
7. Water from outside a drainage district cannot be drained through this crossing if the tile connects to a drainage district tile system; and,
8. Any and all agreements or easements between the Applicants regarding damages, expenses or use of the aforementioned tile line shall be by a separate agreement executed by the parties hereto and shall be provided as an exhibit to this agreement.
- 9. Applicant is required to submit a \$100 nonrefundable fee with this application.**
